Agenda item 3 - Routeing measures and mandatory ship reporting systems (6.24)

- The Sub-Committee will be invited to consider proposals for new or amended routeing measures and mandatory ship reporting systems. Due to time limitations, the Sub-Committee will be invited to consider only proposals requiring urgent consideration. Members submitting proposals are invited to take this into consideration.
- 5 Members submitting proposals for new or amended routeing measures for consideration by the Sub-Committee are requested to provide, together with their submission:
 - .1 the information specified in paragraphs 3.8 to 3.16 of the *General provisions* on *ships' routeing* (resolution A.572(14), as amended), taking into account other applicable guidelines approved by the Organization;
 - .2 electronic copies of the reference charts listed in the description of the proposed routeing measures showing the new systems or amendments to existing systems for use during the session when considering the proposed measures in accordance with paragraph 3.2 of the *General provisions on ships' routeing* and retention by the Secretariat for use when preparing future amendments to the IMO publication on *Ships' Routeing*; and
 - .3 if the proposal is made in relation to Particularly Sensitive Sea Areas, the information specified in sections 4, 6 and 7 of the annex to the Revised guidelines for the identification and designation of particularly sensitive sea areas (resolution A.982(24)).
- 6 Proposals regarding ship reporting systems for consideration by the Sub-Committee should take into account the *Guidelines and criteria for ship reporting systems* (resolution MSC.433(98)).
- Members submitting proposals are advised to take into account the *Guidance note* on the preparation of proposals on ships' routeing systems and ship reporting systems for submission to the Sub-Committee on Safety of Navigation (MSC/Circ.1060 and MSC.1/Circ.1060/Add.1), as well as the *Procedure for the submission of documents containing* proposals for the establishment of, or amendments to, ships' routeing systems or ship reporting systems (MSC.1/Circ.1608).

Further information on the arrangements for the intersessional meeting of the Communications Working Group will be communicated in due course.

 - .2 the need for amendments to resolutions A.706(17), as amended, and A.1051(27), as amended, and other resolutions, to address broadcast monitoring requirements.
- Other issues concerning dissemination of MSI and SAR-related information over multiple GMDSS recognized mobile satellite services, in particular, on how to spread the cost of dissemination of MSI to ships and/or to eliminate the shore-to-ship charge for MSI, will be considered by MSC 103. Members submitting documents to NCSR 8 are invited to take this into consideration.
