Subject: International Day for Women in Maritime 2024 and Gender Equality

Award Ceremony (17 May 2024).

- In furtherance of resolution A.1147(31) adopted by the IMO Assembly on 4 December 2019 on *Progressing the legacy of the World Maritime theme for 2019 and achieving a barrier-free working environment for Women in the Maritime Sector*, the IMO Assembly at its thirty-second session, adopted resolution A.1170(32) on *International Day for Women in Maritime* proclaiming 18 May every year as the International Day for Women in Maritime.
- The observance celebrates women in the industry with a view to the continued promotion of the recruitment, retention, and sustained employment of women in the maritime sector, to raise the profile of women in maritime, strengthen IMO's commitment to the United Nations Sustainable Development Goal 5 (Gender Equality) and to support ongoing work to address the current gender imbalance in the maritime sector.
- Against the foregoing background, the Secretary-General is pleased to announce that the theme for the Day will be **Safe Horizons: Women Shaping the Future of Maritime Safety**, which recognizes the crucial role women play in enhancing safety measures, whether through their roles as seafarers, maritime professionals, or in leadership positions. A half-day symposium will take place under the same theme in IMO Headquarters (4 Albert Embankment, London SE1 7SR, United Kingdom), within the margins of the Maritime Safety Committee's 108th session, on 17 May 2024, from 2.30 p.m. A detailed programme for the event will be issued in due course.
- 4 The symposium will be conducted in person, in all six working languages of the Organization (Arabic, Chinese, English, French, Russian and Spanish). In-person participation in this event is open to representatives from Member States, observer organizations (intergovernmental and non-governmental) and the United Nations and its specialized agencies.
- 5 Delegates intending to participate are kindly requested to register via the Online Meeting Registration System (OMRS) by Wednesday, 15 May 2023. Further information on the registration procedures can be found in the annex to this circular letter.
- At the conclusion of the Symposium, the Secretary-General will be presenting Ms. Despina Panayiotou Theodosiou, nominated by Cyprus, with the IMO Gender Equality Award 2024, per the decision of the Council at its 130th session. A reception will follow the Award Ceremony at 5.30 p.m.

Online Meeting Registration System (OMRS)
